The following is an itinerary for consigned horses in the Sandhills Select Horse Sale:

- Check -in of horses begins at the Gordon Livestock Auction Market on 8:00 AM
- Stalls will be provided only upon request
- Live preview of sale horses will begin promptly 9:00 AM 5/23/10 at the Sheridan County Fairgrounds. The preview is quickly becoming a major promotion time of all horses in the sale. Cattle will be provided for any rope horses. Barrels and poles will also be available. For other specific needs we will certainly try to accommodate you.
- Sale will begin at 1 PM. at the Gordon Livestock Auction Market with the preview held at the Fairgrounds.
- Consignment deadline is first 100 head of select saddle horses approved by the Sandhills Select Horse Sale Committee with consignment deadline date April 1st or a maximum of 100 head. Consignments will be accepted on a first come-first serve basis.
- Original registration papers, consignment sheet & fee and photo must be received to guarantee a sale position and advertise the horse as being in the sale. There will be no refunds of catalog fees after April 1<sup>st</sup>.
- Good original photos, emailed or on photo paper, 4"x5" (300 dpi if emailed, jpg, ) are appreciated and important to the promotion of the horses in the fliers and the catalog. )photo's may not be returned)

All horses sold through the sale ring must be guaranteed sound and be sold with horse qualities as described by written description or verbal qualities while in the sale ring. This guarantee will give the buyer until May 30, 2010 at noon to return any horse not meeting these qualities. Sandhills Select Horse Sale Committee will make the final determination as to soundness of the horse.

We welcome any idea's you may have at any time to make the sale a bigger and better success. Please forward names and addresses for you local area saddlery or tack sores that will display fliers and poster for the Auction as well as any potential buyers that already or may have an interest in your horse  
No sale #'s will be used – if your horse is sold to a buyer # between 1 and 100, then your horse is a no sale.

## AUCTION INFORMATION

**CATALOGUED HORSES:** Consignment period begins March 1<sup>st</sup> with consignments being accepted on a first come first serve basis up to a maximum of 100 head. Sandhills Select "Gentle Gelding" Horse Sale reserves the right to refuse any horse not meeting the sale quality. Consignments must have consignment sheet, fee paid and photo to be accepted.

### **PROPER PAPERWORK:**

All horses must have a coggins test current within six months of sale date.

All horses coming from a brand state & out of Sheridan County must have a Brand Inspection.

All out of state horses must have current Health Papers to enter sale premises. NO EXCEPTIONS.

**PRIVATE SALES:** Absolutely no private sales in the yards before or after the auction. Management feels this is unfair to the buyers who have traveled to attend the sale. All horses brought to the sale must be consigned and go through our auction ring. We will leave it up to the integrity of the seller to forward any commission on horses that go through the ring as no sales, but are sold because of the advertising and efforts of the sale.

**HORSE COMMISSION:** There will be a consignment of \$150.00 per head for all horses. This fee will be non-refundable. A 8% commission will be charged on all horses sold. There will be a no-sale charge on horses of \$150 in addition to the consignment fee. Animals that are rejected by the buyer because they are misrepresented in the ring will be charged 8%, same as if sold. Our veterinarian must check these animals and will make the final determination whether there was misrepresentation. All horses will be charged a \$1.00 brand inspection fee by state law.

**GUARANTEE:** Each Horse sold at the Gordon Livestock Auction Market, Inc. will be guaranteed sound by the consignor. If the horse is not considered sound, the buyer has until May 26, 2010 to have the horse inspected. If the horse is considered unsound, the buyer will be returned his purchase price, less fees. The seller of an unsound horse will not be paid for the horse and will be responsible for any feed in conjunction with the sale fees. The buyer will be responsible to pick up the horse by May 26, 2010, or daily stall and feed costs will be due. Each consignor will be totally responsible for guarantees they make on their animals. The guarantees of each animal will be made only from the auction block while the animal is being sold. Absolutely no guarantee or warranty will be expressed or implied by the auctioneers or ring men. If you are not happy with these guarantees, please do not consign your horse to this sale.

**WARRANTY:** The buyer assumes full ownership of the animal from the time it is sold in the sale ring and is responsible for proper feed and care.

**CONSIGNORS' CHECKS:** All consignors' checks will be mailed out within 10 business days of sale date. This allows time to verify any lien positions of the legal owner of the horse.

**CHECK-IN, PREVIEW, SALE;** All horses must be checked in by May 23 at 8:00 am  
Stalls will be available, by request only, and stalls will be available at Sheridan County Fairgrounds.  
Live preview of horses will held at the Sheridan County Fairgrounds and will begin at 9:00 AM  
Horse Sale will start promptly at 1:00 PM and will be held at Gordon Livestock Auction Market, Inc.

**LOADING OUT:** Buyers must have a release from the office for all load outs. Trucker and load out man must sign all load out slips. Brand Inspector will be on sight on sale day. All horses must be removed from grounds by 10:00 PM

**LIABILITY:** Buyers, sellers and spectators are cautioned to exercise care while attending the sale and enter premises at their own risk.
